General sales conditions 2019

BOOKING YOUR STAY : Booking becomes definitive only after our written confirmation, on receipt of rental contract completed, signed and accompanied by payment. **PITCH :** you can arrive on any day, after 1pm ; a new day is counted from 1pm. Minimum reservations of 1 week in July and August. A deposit of 30 € is payable on arrival after which you will be given an entry badge. A deposit of 50 € is payable on reservation, the balance being due on the eve of departure.

RENTAL : Accommodation bookings are from Saturday to Saturday. Arrivals are from 4pm and departure before 10am. In low season, depending on availability, short stays of a minimum of two nights can be booked. There will be no reductions for late arrivals or early departures. A deposit of 25% of the total cost is payable on booking. The balance being due one month before arrival. In the case of late booking (less than 30 days before arrival date) the full fee must be paid on reservation. On being given your keys, a deposit of 200 € will be asked of you to cover any eventual breakage of equipment or loss of entry badge as well as a 'cleaning' deposit of 52 €. These will be returned to you on departure, less any costs incurred by breakages or loss of equipment, loss of badge or extra cleaning charges. **CANCELLATION :** Under article L.121-20-4 of consumer code, all the services proposed on Website are not subject to withdrawal right allowed for in articles L.121.20 and following of consumer code. Consequently, the services of accommodation and leisure ordered on this site are exclusively subject to below cancellation conditions. **IN CASE OF CANCELLATION,** you must warn the campsite in writing (not e-mail) within 24 hours if you must cancel your stay due to accident or other disaster. In the case of cancellation more than 30 days before arrival (date on rental contract), the deposit and insurance fees will be forfeited. In the case of cancellation less than 30 days before arrival (date on rental contract) the price of stay and insurance fees will be forfeited. If you have subscribed a cancellation insurance, sums paid will be reimbursed (except for insurance fees) in compliance with the conditions fixed by the cancellation/interruption policy (Axelliance Business Services 61, rue du Port - BP 80063 33260 LA TESTE DE BUCH - Tél 0811 88 55 60) as follows : Before arrival : 25% for a cancellation more than 30 days before arrival date or 100% if you have to cancel less than 30 days before arrival date. During your stay : you will be reimbursed the sum that corresponds with the remaining part of your stay and already billed by the campsite.

CANCELLATION /INTERRUPTION INSURANCE : The campsite offers you optional Cancellation and Interruption insurance in your rental contract. In case of cancellation, please notify the campsite of your cancellation as soon as an event occurs that prevents your departure, by letter or by email. If the claim is covered in the general conditions (available at www.campez-couvert.com or from the campsite), please notify the insurer within 48 hours and provide all the necessary information and supporting documents.

SWIMMING POOL : The swimming pool being unsupervised, children are entirely under their parents responsibility. Swimming shorts are not allowed at the pool. **ANIMALS :** Dogs and other pets, tattooed and vaccinated, are accepted (except category 1 breeds like Pitt Bull and attack dogs such as Rottweiler); they should never be allowed to roam free or be left alone on the campsite during your absence even if tied up. They must be kept on a lead at all times. They are forbidden around the swimming pool, children's play area and shower blocks. **BARBECUE :** Portable charcoal barbecues are strictly forbidden except in the designated area. **NOISE LEVELS :** You are asked to refrain from any noise or conversation which could disturb neighbours. We ask for total silence from 10pm until 7am. **CARS :** No vehicles should circulate on the campsite between 10pm and 7am. **EQUIPMENT INSURANCE :** It is recommended that you insure your fixtures and fittings against theft and weather damage. If you are renting accommodation you must insure it and check with your insurance that your domestic insurance covers you for holiday lets. Proof of insurance cover will be asked of you when you are given the keys to your accommodation. If you fail to produce this, you will be asked to sign a paper saying that you have this insurance. **MINORS :** Unaccompanied minors from their parents, they are not accepted on the campsite.

VISITORS : After having been authorised and signed in at reception, and having left their vehicle in the car park, visitors are allowed on to the campsite, but not on the swimming-pool. They are the responsibility of the camper receiving them. They will be asked to pay for the use of the campsite's material and services. **RIGHT IMAGE :** During your stay, you may be photographed or filmed on our site. We may use such photographs or films to commercial or advertising purposes, unless you indicate in writing to the reception on arrival your opposition to this practice. **MEDIATION OF CONSUMER DISPUTES :** In accordance with the provisions of the Consumer Code concerning "the process of mediation of consumer disputes", the customer has the right to use the mediation service proposed by the campsite free of charge.
